**SUBJECT:** Apportioning Representatives Among States by Citizen Populations Instead of Total State Populations

In response to congressional inquiries, this memorandum provides an estimate of the impact on House apportionment if the word "citizens" had been substituted for "persons" in Section 2 of the 14<sup>th</sup> Amendment prior to the 1990 and 2000 Censuses. Section 2 reads, in part, "Representatives shall be apportioned among the several States according to their respective numbers, counting the whole number of persons in each State, excluding Indians not taxed."

The Census Bureau derived its estimate of the number of citizens counted in the 2000 Decennial Census from answers to question 13 of the Census 2000 "long" form (question nine in 1990), which was sent to approximately one-sixth of U.S. households. If the 14<sup>th</sup> Amendment had been amended to require Representatives to be apportioned among the states based on citizenship, rather than total population prior to the 2000 Census, the Census Bureau probably would have asked this question of all households, rather than a sample, because the Supreme Court ruled in 1999 that the Census Act<sup>1</sup> prohibits sampling for use in the apportionment of the House of Representatives.

If the citizen population had been the basis for apportionment after the 2000 Census, it is estimated that nine seats would have shifted among 13 states. In 1990, eight seats would have shifted among 10 states. Population figures and apportionment totals are shown in tables 1 (2000) and table 2 (1990). The states that would either gain or lose Representatives are listed below.

- **2000.** California would have received six fewer Representatives than it actually did. Three other states would have lost one Representative: Florida,

New York, and Texas. Nine states would have gained a Representative as compared with the actual 2000 apportionment: Indiana, Kentucky, Michigan, Mississippi, Montana, Oklahoma, Pennsylvania, Utah, and Wisconsin.

- **1990.** California would have received five fewer Representatives than it actually did. Florida, New York, and Texas each would have lost one Representative. Eight states would have gained a Representative as compared with the actual 1990 apportionment: Georgia, Kansas, Kentucky, Louisiana, Michigan, Montana, Ohio, and Pennsylvania.

## Caveats

Modern U.S. censuses are not conducted primarily by enumerators; instead, questionnaires are mailed to each residential address, and someone answers the questions for each person living at the address. Since the Census Bureau relies on census respondents to answer accurately the questions on the census form, the bureau's 2000 estimate of 18.5 million non-citizens (6.6% of the total U.S. population) has not been independently verified.

This memorandum does not examine the impact of excluding only the unauthorized immigrant population from the apportionment population. Estimates of this subgroup of the non-citizen population cannot be derived from census data because the Census Bureau did not ask an immigration status question in the 1990 and 2000 Censuses. The Immigration and Naturalization Service<sup>2</sup> estimated that approximately seven million unauthorized immigrants were in the country as of January 2000.<sup>3</sup> The INS estimate was derived by comparing 2000 Census data with INS statistics.

The population figures used to compute an apportionment based on each state's citizen population do not include federal employees who were stationed abroad (chiefly military personnel and their dependents, totaling 574,330 persons in 2000 and 919,810 persons in 1990). In 1990 and 2000, the Census Bureau included these people in the state populations used to reapportion the House.<sup>4</sup> The administrative records used to count the overseas federal employees in the 1990 and 2000 censuses did not include their citizenship status.

## Tables

Tables 1 and 2 set out the state populations used to apportion the House of Representatives after the 1990 and 2000 Censuses: the census apportionment populations (including overseas federal employees), the resident populations, and the estimated citizen

populations. They also illustrate the difference between the resident and citizen populations (shown by total and percent), the House seat allocations after the census, and what they might be if the House had been reapportioned based on the citizen populations.

Tables 3 and 4 show the total Census resident population for each 109<sup>th</sup> and 103<sup>rd</sup> Congress congressional district, the citizen population (including native born, and naturalized), the non-citizen population, and, the citizen population proportion of the each district's resident population.

Some proponents of excluding non-citizens from the apportionment population find an inequity in the differential impact in the number of votes cast in congressional districts with large non-citizen populations as compared to districts with relatively few non-citizens.<sup>5</sup> Tables 3 and 4 also report the total vote cast for all candidates in the 1992 and 2002 general elections. These general elections were chosen for this analysis because they were the first election in the decade based on the districts drawn after the 1990 and 2000 Censuses. Voter registration data would probably be a better measure than turnout to compare with citizenship data because the registration data are less likely to be influenced by external factors such as

political advertising and the circumstances of particular races, but voter registration data are not consistently reported by congressional districts.
